
CARRYING CAPACITY (KILOMETERS) OF STATE TRANSPORT UNDERTAKING FROM LAST FOUR YEARS:




LOAD FACTOR OF STATE TRANSPORT UNDERTAKING FROM LAST FOUR YEARS:






PASSENGER LOAD (IN KM)OF STATE TRANSPORT UNDERTAKING FROM LAST FOUR YEARS:



- 2) Declining load factors due to competition. it faces competition from private bus operators and other private vehicles like Auto-Riksha etc. Declining of Load factors affecting on its financial performance of STUs.
- 3) Load factor of STU is highest 68.77 % in the year 2012-13. Then it falling to 67.73% in the next year 2013-14.
- 4) Average passenger in kilometers from last four years is 54778.52 crores.
- 5) Passenger load of State Transport Undertakings is increased to 0.03 from 2012-13 to 2013-14. It is decreased to 0.88 in the year 2014-15.
- 6)Passenger carried is decreased by 159.71 crores in 2013-14 as compared to previous year 2012-13.It is increased in next year i.e. 2014-15 by 147.45 crores.
