
# Analysis

Fig. 1: High & Low Socio-Economic Status & Personality




Hence the null hypothesis stated above is rejected. Thus the above table shows that the high and low SES students differ in their personality dimensions.

Fig. 2: High & Normal Socio-Economic Status & Personality




Hence the null hypothesis stated above is rejected. Thus the above table shows that there is significant difference in the personality of adolescent music students having high and normal socio-economic status.
