It has been suggested in the prior art that the effectiveness of enzymatic drainage cleaner should be improved by including an effervescent couple in the composition. This effervescent couple consisting essentially of a weak organic acid and the alkali or alkaline earth metal salt of carbonic acid such as carbonic acid, such as sodium bicarbonate will react to generate carbon dioxide gas when it contacts water. The bubbles of carbon dioxide can tend to mechanically loosen and remove the particle of then deposit near the surface where have been attacked by the enzymes. The actions enable the enzymes to more effectively penetrate the deposit. The prior art effervescent couple, however, has some disadvantages. First, the effervescent couple started to generate copious quantities of carbon dioxide gas substantially immediately upon coming in contact with water. A moveable cleaning system enables cleaning of relatively flat surfaces, and especially elevated and/or sloped and/or vertical surfaces without the use of personnel at the specific site of cleaning. System can be fully automated, with programming set to enable the system to clean an entire surface or structure (e.g., an office building or hotel) or allow system control by someone distal from or proximal to the direct point of application of the cleaning activity. According to this invention, the conveying screw is hollow and is provided at its delivery end with tightly fitting slidably mounted torpedo pin which projects partially into the chamber in axial alignment with the screw. A spring is also mounted in the bore of the screw in such a manner that one end of the spring engages the head of the torpedo pin and the other end of the spring engages a threaded plug adjustably mounted within the screw. Thus, the torpedo pin is urged by the spring in the direction of the chamber. Water is essential to life, for both plants and all living creatures; however it can be very invasive when it flows. When residential property experiences drainage issues, water can be a nuisance and actually cause a great deal of damage. Different drainage system problems, including puddling, pooling, and saturated soil, and even undirected downspout water, can destroy landscaping and turn a backyard into a swamp.

Prof S.D.Anap, et.al. [20], showed blockage is the major cause of the pollution and flooding in the metro cities. They explained about the design of the cost effective, easy method to control the water level of the tank wirelessly and automatically. They have designed the drainage blockage detection system to avoid such problems.

James C.Y. Guo, et.al. [21] Showed roadway sanding is a common practice in cold regions because sand increases the roadway friction when mixing with snow. This study also presented a maximization methodology by which the size of snow storage

area can be determined by the diminishing return of sand recovery. In this study, a snow storage element is introduced to the renaissance project of a mountainous highway which is running through an environmental sensitive forest area in Colorado.

James C. Conwell, G. E. Johnson [22] proposed the design and construction of a new test machine configuration that offers same advantages over the traditional one. The incorporation of idle sprocket allows independent adjustment of test on length and preload.

N.Prabhushankar, et.al. [23] The main aim of the proposed work was to remove drainage water by the pneumatic operated spring return reciprocating pump. Showed dewatering of drainage is generally done using centrifugal pump, but using centrifugal pump is not much effective in complete removal of the suspended and heavy solids and also it consumes lot of electric power for its operation. III. METHODOLOGY

The device is placed across drain so that only water flow through screen, the waste like bottles, plastic etc. Floating in drain are lifted by lifter which is attached with screen. Screen is connected to the shaft which is driven by chain with the help of DC motor. When motor runs the chain start the circulation making screen with lifter to lift up waste, further it is connected to a horizontal screening and waste stored in a container.

PROCESS:

When the current is supplied to motor, motor starts to rotate, Rotary motion of the shaft is transferred to sprocket by the help of chain. By the help of upper sprocket the rotary motion is transferred to lower sprocket using chain. The lifter is used to lift the plastic waste from the drainage are placed between two chains. When motor is switched on the two shaft start to rotate, thus the lifter also start rotate. The lifter enter into water and lift the plastic waste from water along it, It carries to waste and drop the waste on other assembly of sprocket, chain and shaft which moves horizontally. The horizontally assembly store the waste to the container from where the plastic waste can be collected.

IV. CONCLUSION

By study of many literature review we conclude that. Many specific empirical studies have been carried out and categories such as automatic drainage cleaning system and its automation have been studied to a great depth. We focus more on making the system in the drainage.
