SOCIAL INTERACTION

In other countries such as France, Greece, Italy, and Spain, made it illegal to leave the home without a permission. These measures affected several rights contained in national constitutions, international human rights law. These mainly impacted on right to liberty, freedom of movement, right to privacy, security and family life. They have also impacted on right to health, mainly on mental health.

HEALTHCARE

It involves providing accessibility to both preventive and medical care. People living in villagesalso faced the difficulties in accessing up of proper healthcare. According to World Health Organization (WHO) report the healthcare workers had been most infected due to this pandemic.

EDUCATION

These mainly impacted on right to children's education and their well-being. Children belonging from poor background could not afford computer and internet access hence the children could not get online education.

STREET VENDERORS

Street venders such as greengrocers, chat sellers, auto-rickshaws, taxi drivers, daily wage laborers, and so on are mostly affected by the pandemic. They were unable to meet their basic

needs, such as food, shelter, and clothing, as a result of the pandemic. As there will be no transportation available during lockdowns, auto- rickshaws and taxi drivers will become unemployed. Lockdowns' adverse effects will affect only those people below the poverty line. These mainly impact on the right to a standard of living, including food, shelter, clothing, and the right to security in the event of unemployment.

OLDER PERSONS

According to the survey (1), The pandemic has had a particularly negative impact on the elderly, particularly those who live in institutions or have underlying medical issues. The death rate was substantially higher in this age group than in others. Older people faced more restrictions relating to physical distance, as well as they were not allowed for the public transportation. This impacted on the physical and the mental health of old age persons and Right to Non-Discrimination based on age.

PERSONS WITH DISABILITIES

Many people with disabilities suffered serious impacts. Pre-existing medical issues raised the dangers of a COVID-19 infection to their lives and health. Those in institutional healthcare institutions were found to be at higher risk, as they were subjected to visitation bans, isolation, and mental stress. The disturbance and reduction of crucial services for people with disabilities was a critical challenge. Education, schools, and other learning support for disabled children, healthcare, community-based and at-home support, and facilitated transportation were among them. Switching to digital and mobile learning and work schedules was also ineffective. It indicated the possibility of a widening digital divide between those with disabilities and the general population.

REFUGEES AND MIGRANTS

The Indian government-imposed lockdown with only four hours' warning. It's a fascinating and unexpected democratic phenomenon. All of this was accomplished without alarming the general populace. All of the migrant laborers were stuck where they were working. Refugees and migrants have been adversely affected. This mainly included children and unaccompanied minors. Evidence demonstrates that overcrowding, poor hygienic conditions, and restricted access to health care increased the risk of illness among all migrant groups.

CHILDREN

According to the report of Hindustan times (5), In Maharashtra, child marriages increased by 78.3 percent despite a state of emergency as families remain poor. Child trafficking has been increased due the pandemic. Trafficking is one of India's most severe organized crimes involving children. Commercial sexual exploitation, bonded labor, marriage, adoption, and organ trafficking are all common causes for domestic and international trafficking. In addition to this, it is critical to protect children whohave been orphaned by COVID-19.

During a pandemic, police personnel are very curious about implementing government orders, but they forget to protect human rights violations. Lathi charges, filing FIRs, and seizing vehicles are the most common actions of police officials, which are very popular during lockdowns and weekend curfews.
