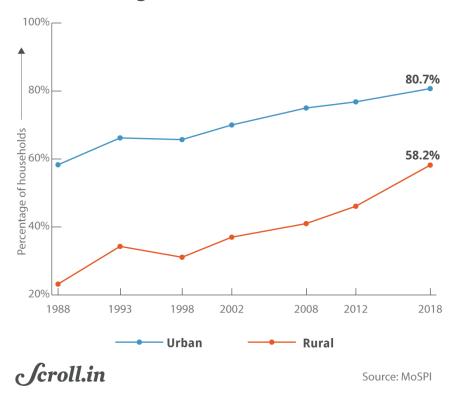

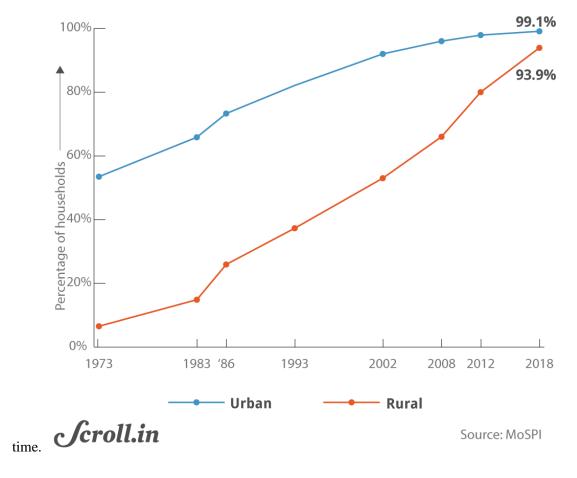

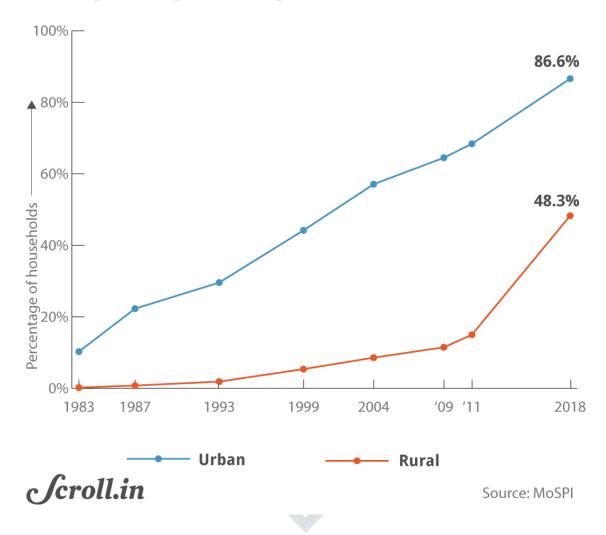

Pradhan Mantri Ujjwala Yojana:- (PMUY) is a social welfare scheme launched by the Government of India on May 1, 2016, with the aim of providing free LPG (liquefied petroleum gas) connections to women living below the poverty line. The scheme aims to replace traditional fuels such as kerosene, coal, wood, and other biomass-based fuels with LPG, which is a cleaner and more efficient cooking fuel. The scheme targets rural women who belong to households that are classified as Below Poverty Line (BPL) as per the Socio-Economic Caste Census (SECC) data. The government provides free LPG connections to the women belonging to these households, along with a stove and a regulator. The scheme has a target of providing 8 crore (80 million) free LPG connections by 2020, and as of September 2021, over 10 crore (100 million) connections have been provided under the scheme. The scheme has several benefits, both for the environment and for the beneficiaries. By replacing traditional fuels with LPG, the scheme aims to reduce air pollution, which is a major health hazard in many parts of the country. 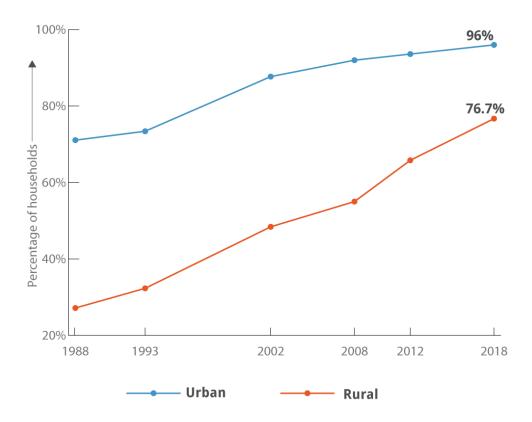
