Prosperity of the Scheme



The total number of applicants across the districts of West Bengal is an impressive 645,844. South 24 Parganas has the highest number of applicants, with 213,750, while Kalimpong has the lowest, with 2,341.

Hundreds of thousands of women across rural and urban West Bengal have enrolled in the state's largest cash transfer scheme, 'Lakshmi Bhandar'. This scheme provides a direct benefit transfer of 500 per month to women of the general category and 1,000 per month to women from reserved categories, offering basic support to female heads of households.
