- 4) The teacher should maintain honesty and authenticity in his working with others
- 5) The teacher should establish and maintain mutual relationship with his students in working
- 6) The teacher should encourage his students to be positive, careful about the self-respect of the students
- 7) The teacher should adapt his teaching style according to the needs of the individual student
- 8) The role of the teacher is vital in shaping the future of not only the individual student but the society at large
- 9) Education is the vital pillar of a developed country. Therefore, the teacher should be the role models for the students.

Again, Aristotle said, "Teachers who educate children deserve more honour than parents." Adam said, "The teacher is a maker of man." #### **Professional Ethics**

Ethics are integral parts of each and every profession.

Ethics refer to the various moral rules governing human relation. The Cambridge Dictionary of Philosophy states that the word ethics is "commonly used interchangeably with morality".... and sometimes it is used more narrowly to mean the moral principles of a particular tradition, group or individual."

Professional ethic can be defined as the optimum standard of behaviour. It also refers to the comprehensive professional ethics that people should follow in the process of engaging in various professional activities and it is closely related to the professional activities. It also reflects the specific moral requirements determined by the professional labour. The addition of knowledge, skill and competency makes a teacher effective in his subject but the teacher can become an ideal man, leader and motivated in this process with the integration of all professional ethics. Mahatma Gandhi once said to the students, "I have found that boys imbibe more from the teachers own lives than they do from the books.........This would not be possible if the teachers do not follow professional ethics attached to their occupations. #### **Professional Code of Ethics for Teachers**

The two important attributes of code of ethics are confidentiality and loyalty. The ethical standard for teaching profession represent a vision of professional practice. The objective of the ethical standard for teaching profession is to inspire the teachers to reflect and uphold their honour and dignity and to guide ethical decisions and actions and also to spread public trust and confidence. The important quality of effective teaching is its commitment to the students and their learning.

As part of the code of ethics, the teacher has a duty to encourage students to learn to the best of their abilities and also to teach social values. Teachers strive for the best possible performance. Teachers must possess all necessary qualifications for accepting a job.

The teacher tries to follow the school policies.

Teachers strive to apply ethical behaviour to their colleagues

They strive to maintain an open, accepting classroom environment for the students.

Teachers should have responsibilities to communicate home with the parents regardless of the community.

Teachers should take part in activities in the adjacent community.

In addition to the above, the teacher should foster healthy relationship with the students, parents, colleagues and school staff.

#### Responsibility towards students

The teacher encourages students in learning, health and safety.

The teacher resolves problem regarding discipline, law and policy.

The teacher must be fair to each student and justify each student equally.

The teacher provides learning equally to each student.

The teacher should have a helping attitude and should be able to guide students in need.

The teacher should listen students concern and problems.

The teacher should realize the highest possible standards of productivity in their students.

They should provide a fair system of grading.

# Responsibility towards Parents/Guardian/Family

The teacher should participate in parents, teachers meeting and discuss the problems of the child.

The teacher should respect the privacy of a family.

The teacher establishes the relationship with parents based on courtesy, mutual trust and communication

The teacher should be truthful in the society.

The teacher should play an active role in the community relation.

# **Responsibility towards Colleagues**

The teacher should have cordial and cooperative relationship with the colleagues

Groupism among the teachers should be avoided.

Do not reveal confidential information about the colleagues.

The teacher should not provide false statements about colleagues.

The teacher should assist, support and encourage new comers for the profession

# **Responsibilities towards Community**

The teacher should inculcate among the students the feeling of brotherhood by organising different programmes i.e. mass literacy, tree plantation etc.

The teacher should hold meeting with the community for awareness programme on various issues of education.

The teacher should provide good citizen to community.

They foster academic integrity

The teacher should use fair and objective assessment.

They should have professionally appropriate relationship with their students.

Hence, the researcher concludes that there is no formula for successful teaching. Every teacher is unique and each has an individual philosophy and teaching style.
