In India, there is a deficiency of appropriate and strict cyber laws to deal with or punish the offenders. Further, due to the technological advancements the law enforcement officers are not in position to detect the cybercrimes and to take timely action.

- Because computer was huge at that time, accessing the information stored in one computer made it difficult for other. so they made ARPANET (Advanced Research Projects Agency Network), which later advanced to be called as Internet.

In the 1970

- By the development Transfer Control Protocol (TCP/IP) , now different computer connected with in different network can communicate with each other.

In the 1983

- The internet was born.

In the 1995

- By this year internet has now established with more than 10 million users around the world.

In the 2000s

- There was a huge change in the field of internet, as the broadband was invented to make internet more dependable and faster.
- And also there was a rise the number of social media platforms.

So let's take a look at how the internet was created before discussing the development of social media. The origin of internet was in 1950s in USA. ## SnapChat

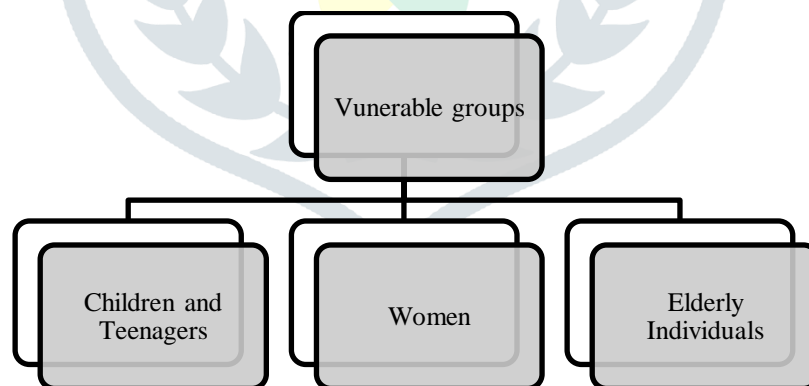

This requires not only to proactive measures to teach children about advanced security but for the strong systems for checking and controlling their online exercises. By recognizing the different forms of computer threats were children are facing and actualizing comprehensive strategies to mitigate them, we are able make a more secure online environment where our children can flourish and develop without fear of misuse or hurt.

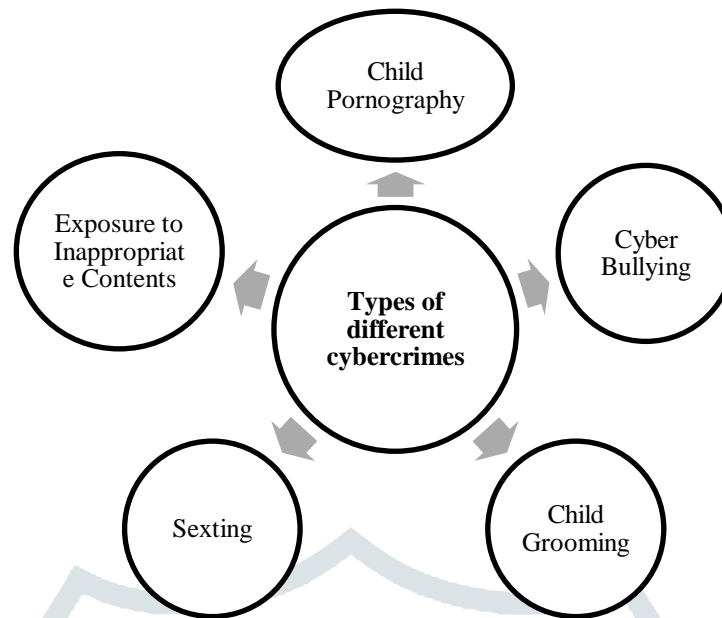
There are many reports and data published in various articles relating to the increase in the crimes against the children and also the harmful effects these crimes have on children. According of NCRB (National crime Records Bureau) 2022, in that it is said that a 32 % of cybercrimes has been increased from the year 2021.Total number crimes in 2022 was 1,62,449; while in 2021, the number was 1,49,404.<sup>9</sup>

When we look in the year 2020, it is said that more than 400% of rise in cybercrimes were reported. If we compare with 2019, only had 164 cases of cyber crimes against children were reported, in 2018, 117 cases of cyber crimes were committed against children and in 2017, 79 cybercrimes were registered. The reason for this increase is that during the Covid-19 pandemic period, to reduce the spread of the pandemic the schools were closed and movements were reduced. As a result the virtual learning environments were introduced. This gave chances to children to spend more time on online for entertainment, social and educational purposes, not necessarily being aware of any risks associated with it.



### 5.1. TYPES OF DIFFERENT CYBERCRIMES COMMITTED AGAINST THE CHILDREN

- i. **Child Pornography**: In this pornography, children are sexually exploited for creating sexually explicit images and videos. It includes production, distribution and watching the contents on online platforms. These types of activities are punishable under the law.
- ii. **Cyber Bullying**: In this social media platforms are used to harass, intimidate or harm children. This can happen in many forms like sending threatening messages, spreading rumors and lies, manipulating photos and videos are some of the ways in which cyber bullying happens. These activities can later cause mental health problems like anxiety or depression which may end up in self-harm or suicidal.
- iii. **Child Grooming**: In this the person makes a relationship with the children for the purpose of gaining trust. Later they manipulate them to get engage in sexual activities and other form exploitation. They use many tactics to gain the trust of the children like attention, gifts, of affection, were their ultimate goal will be sexual abuse or exploitation. These can have serious and long-lasting effects on child, causing emotional trauma and psychological harm.<sup>10</sup>
- iv. **Sexting**: It means with the help of phone or computer texting in sexy manner to other people is called sexting. It can also include sending photos. Problem is that, these photos or texts might get leaked or there is chance of blackmailing the children with these as a proof and asking them or forcing them for more advancement.<sup>11</sup>
- v. **Exposure to Inappropriate Contents**: Inappropriate contents can be anything that are harmful or not appropriate for their age group. By exposure to that content it can affect their mental capacity, like watching any content of violence in nature then that can influence the mind of the children and also affect their thinking capacity. Not only violence but also anything of sexual content can have same effect on children.<sup>12</sup>

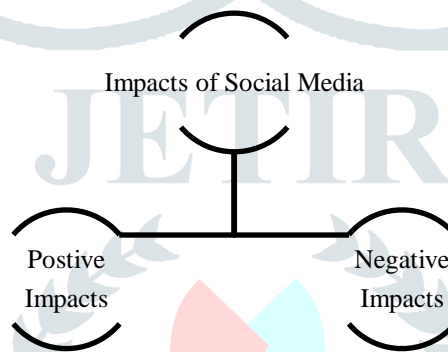


## 6.1. IMPACT OF SOCIAL MEDIA ON CHILDREN

Social media has many positive aspects, but it has also brought about some serious drawbacks, like worries about security and privacy, developing mental health issues with mental health, and the spread of false information. These difficulties may result in polarization in society, emotional distress, and the misuse of personal information. Fostering a more secure and equitable online environment requires addressing these problems.

- i. **Addiction to social media:** This is one of the most important impacts on children, that are addiction to these platforms. They constantly checking their accounts and always getting engaged on these platforms are very common nowadays. It is reported student spend more than 2 hours daily on these platforms.
- ii. **Effects on academic:** This is another effect by the use of social media, as because of the addiction it can directly effects academic of the children. Not only the academics but also in sports and other productive activities which is helpful for the growth of children.
- iii. **Effects on Mental health:** It is also observed that social media have caused many mental health issues in children like feelings of inadequacy, loneliness, and anxiety, leading to mental health issues such as depression and anxiety disorders.
- iv. **Lack of social skills:** Excess social media utilization can prevent face-to-face communication. It diminishes openings to create vital social skills. Children may battle with communication, sympathy, and conflict resolution. Driving to challenges in shaping and keeping up significant connections.<sup>14</sup>

### 7.1. ROLE OF PARENTS IN MEDIATING AND MONITORING

Parents play an increasingly important role in mediating and monitoring their children's and teenagers use of social media as a result of their increased engagement with these platforms. It is the responsibility of parents to help their kids navigate the digital world in a safe and responsible manner, weighing the advantages of connectivity and information access against potential hazards like exposure to inappropriate content, cyber bullying, and privacy concerns. This duty entails teaching children digital literacy, establishing limits, keeping an eye on their activities, and encouraging a positive balance between online and offline relationships. Parents can guarantee that their children have positive, safe, and enriching experiences on social media by playing an informed and active role in their lives. But the problem is that not every parents are aware of the emerging technologies. There are some parents that have limited knowledge on how does the internet and social media works and also the risks associated with it. This is the main reason why many children are not aware of the risks and get trapped in these social media crimes. So first there should be awareness class for the parents and teaching them on how to monitor their children's online activities.

### 8.1. CASE STUDY

#### 8.1.1. Ahamed Mubashir v. The State Of Kerala on 5 April, 2024

The prosecution's case is that on October 4, 2020, the messaging app in accused's mobile phone contained child pornographic images and videos, which were found by the Inspector of Police at Info Park Police Station. The Cyber Cell in Kochi City provided this information. After conducting an investigation, the Police produced a final report in which they charged the accused with breaking several laws, including Sections 15 of the POCSO Act and Sections 67 and 67-B of the IT Act. The petitioner challenges the final report and the order dated 1.11.2022 in CMP.No. 468 of 2022, an application seeking discharge, from the Court of Additional District and Sessions Judge, Ernakulam was filed.

The court held that petitioner in this case has violated Sections 15(1) and 15(2) of the POCSO Act as well as Section 67-B(b) of the IT Act, the court said. The prosecution's case is that there were videos and pictures of young girls in their underwear on the accused's phone. The prosecution has made specific allegations that the petitioner intentionally stored child pornographic content.<sup>15</sup>

#### 8.1.2. Ms X v. State & Ors. on 20 October, 2020

When the petitioner enrolled in a prominent school in Delhi at the age of sixteen. She got to know a boy who was taking the same course. She and he quickly became close friends after that. However, he wouldn't allow her to talk to anyone else because he was so protective of her. He had repeatedly taken her phone and read all of her messages. She states that the defendant started emotionally blackmailing her and threatening to commit suicide if she did not give him access to her personal images. Having given in to the above strategies, she started sending him her "intimate pictures". According to the petitioner, she decided in 2019 to pursue her education in Melbourne, Australia. She claims that she learned that the accused had posted her private photos on YouTube, Instagram,

Twitter, and other platforms in October or November of 2019. She claims that the accused had misused the images by putting them online, and the uploaded pictures were the same ones she had sent to the accused when she was a minor.

This court ordered the respondents, Facebook, Google, and YouTube to ensure that the URLs listed in the petition are removed. The offensive images of a young girl on the webpages were undeniable. This led to the issuance of an order. It appears that a number of users other than the accused have uploaded and shared the offensive photos widely. This highlighted how urgent it is to stop the dissemination of offensive content on internet platforms.<sup>16</sup>

### 8.1.3. Fathima A.S. v. State of Kerala (2020) 4 KLT 617

The applicant was the mother of two older children, a girl, eight years old, and a boy, fourteen years old. She gave them permission to paint her bare body. The video was captured by the accused, who then shared it on social media. The mother's counsel has argued that her goal was to educate them about body positivity and sex education in India.

However, the court held that the video would violate the POCSO Act 2012 since it employs minors for sexual gratification. They further stated that there would have been no crime committed if the act had taken place inside their home's four partitions. The court said that after hearing both sides has dismissed the application of section 438 of the Code of Criminal Procedure, 1973.<sup>17</sup>

## 9.1. CONCLUSION

In this computerized age, the rise of different social media crimes has cast a shadow over the innocence of childhood. Cyber bullying, online grooming, and exposure to inappropriate content are some example of cases that are targeting children within the virtual world. These crimes not only affects safety and security but also leaves a scars that can ruin their development and improvement. These can affect the academics performance and social development due to the anxiety and depression cause by the after effects of these crimes.

In addition, the predominance of social media crimes underscores the critical need for proactive measures to secure our children from online crimes. Parents, teachers, and policymakers must collaborate to set up strong shields and directions that prioritize the security and well-being of children. This incorporates advancing computerized education, teaching responsible online behavior, and assisting children for help and supports them when they faced cyber dangers. By cultivating a culture of awareness and responsibility, we will engage children to explore the advanced with confidence and strength.

Eventually, addressing to the issue of social media crimes against children requires a multi-faced approach that includes education, legislation, and community involvement. It is necessary that we recognize the seriousness of these violations and take concerted activity to prevent them from happening within the first place. Every child deserves the right to be safe and sustaining online environment, free from the hurts of cyber abuse and exploitation. By working together to combat social media violations, able to endeavor to form a brighter and more secure future for our children, both on and offline.

## 10.1. RECOMMENDATION

- i. Parents should monitor their children's social media usage, teach them about online safety, privacy settings, and personal information risks.
- ii. Enforce age restrictions content and provide with appropriate content.
- iii. Implement digital literacy programs to teach online privacy, digital citizenship, and critical thinking to the children and also to the parents.
- iv. Stakeholders should regularly assess the effectiveness of children's social media privacy protections and make necessary adjustments to address emerging challenges and threats.
- v. Collaboration among social media companies, parents, educators, policymakers, and child advocacy groups is crucial for developing comprehensive solutions to safeguard children's online privacy.
