Abstract

Stock Verification is an essential part of library management that ascertain to check the library resources in the stock. It is an effective method to identify mistakes and prevent fraudulent procedures. The purpose of this article is to investigate the potential and intensive stock verification of more than 60000 documents of Mandya University Library. Study results reveal that 39127 library books are available in the power house of new library building constituent government college of Mandya university library and 23060 books are discarded as loss of books. Notable findings shows that insufficient knowledge of cataloguing and classification rules has hampered the quality of Mandya University Library caused by the inactions of strategies, lack of professional trained library staff and policies. This study also provides a description of the technology used and the architecture of NewGenlib 2.1. Integrated Library Management Software (ILMS). The major problem that Mandya University Library had with vendors was largely due to factors related to cost and support. It is noted that technical support for the integrated library systems was either not available or unreliable. To assist in identifying significant areas of loss, the study also emphasizes how administrative rules for collection evaluation and management policy can be framed by using traditional

document verification. This article advocates the earnest need to appoint a permanent or consolidated university librarian, professional trained library staff, university library budget plans, college budget plans, establish digital resources and services, and a college library association to make the right decisions.

Introduction

Mandya University, an Autonomous Government College located in the centre of Mandya city road, is a challenger that aspires to provide higher education by removing common barriers to enable students to succeed. It is committed to provide affordable quality education with a deep commitment to diversity, equity, inclusion, and social justice. Libraries and information centres provide a wealth of resources and educational programs to promote lifelong learning and information literacy. It is a testament to the marvels of modern technology that offer access to diverse and authoritative sources of information, assist with research and reference services, and provide instruction to enhance information literacy skills. University library is where students' research takes root, futures are shaped and the magic of learning ignites young minds. Mandya university library is a spectacular structure that has been elegantly built to serve as a focus for academic research, teaching, and learning in the education discipline. It is a prime destination that students and faculty can rely on as their "go-to" resource. This outstanding new library building is invaluable because it allows students, faculties and principals to find specific books, journals, videos, dissertations, and more without having to switch platforms.

Libraries and information centres perform annual stock verification to ensure that their collection is up-to-date and accurate, which ultimately enhances the overall efficiency of library services. By conducting stock verification, libraries can identify that all inventory and resources are accounted for and in good condition, reducing the risk of lost or damaged materials. Accurate stock verification allows libraries to better serve their patrons by ensuring that the resources they need are readily available and easily accessible. This process is crucial for maintaining an organised and functional library system as well as providing quality service to patrons. Regular stock verification can assist libraries in making informed decisions about collection development and resource allocation, with each decision reflecting concern for the greater good of the library user community. Stock verification demonstrates the importance of professional and qualified library staff being knowledgeable about advanced technologies and digital resources to ensure timely information flow to students, faculties and principals.

The Significance of Professional University Librarian

A professional university librarian plays a pivotal role in curating resources that cater to the diverse needs of students and faculty members, ensuring that the academic community has access to relevant and reliable information. Their expertise in information literacy also helps guide users through the vast sea of

knowledge available, fostering a culture of critical thinking and lifelong learning within the university. The start of this lies with the state government's decision to employ a permanent or consolidated university librarian at Mandya University. The only way to make sense of change is to plunge into University librarian designation and move with it. An experienced university librarian can offer library users a single platform with access to high-quality, multi-format academic content, simplifying research workflows and enhancing the library's scholarly resources. This ultimately contributes to the overall success of students in nurturing talent, fostering innovation, and providing a platform for growth.

Mandya University Library needs a permanent or consolidated university librarian and professional trained library staff to shape the future of technology and enhance the digital world at an unprecedented pace. This realization is liberating and empowering, as it places the keys to the students' upbringings and supports faculties in building essential skills to explore new ideas. Government College, an autonomous new library building is the future incredible information resource centre of Mandya University, and without a professional qualified university librarian, the chances to build resilience will vanish. This article discusses the process of stock verification in the Mandya University library, which helps identify library losses, rectify incorrect book placement, and redefine library policies. It highlights the importance of proper checking at the entrance and borrowing of books and suggests that this process will be beneficial for any library seeking to check their stocks and maximise the effectiveness of library resources. Mandya University Library and Information Centre hub needs consolidated or professional and qualified library staff to adapt to the rapidly evolving digital world.

Objectives of the Study

The primary goal of this paper is to assess the current state of Government College, an autonomous new library facility in the Mandya district. The specific objectives of the study are as follows:

1. To verify the current stock of library resources against the accession register and documents (print or online) in the Mandya district.
2. To know the personnel management of the Government college, autonomous.
3. To identify the current state of application and usage of NewGenLib software.
4. To emphasize the importance of information about maintaining reference books for reading.
5. To clarify the use of library amenities and providing information about library policies.

Review of related literature:

A literature review promotes intellectual growth, synthesizes existing knowledge, and identifies gaps, leading to more robust conclusions and recommendations applicable in the real world. Brown-Syed (2003) suggested annual or regular stock verification and inventory of library data equipment as a security measure for maintaining library integrity and value. Kumbhar and Bidve (2016) found that libraries use accession numbers for stock taking, preventing loss, maintaining accurate records, withdrawing lost

volumes, and facilitating collection, restoration, and user service. Sarma and Sarmah (2016) carried out a study on the best practices of college libraries affiliated with Dibrugarh University in Assam and found that most of them have implemented automation, NLIST subscriptions, library bulletin boards, webpages, and suggestion boxes. Dabas et al. (2003) examined library automation in nine Indian university libraries, focusing on digitization and hardware and software availability. Authors concluded that all nine libraries are moving towards automated systems, with INFLIBNET playing a crucial role. Khalid et al. (2018) proposed a digital model for Higher Education Institutions (HEIs) to adapt to technological advancements, the necessity of digitization, which involves technology interventions to enhance access to information sources, preservation, and dissemination at any time, place, or location. Randhawa (2008) asserted that open-source software is a type of computer code freely available to users under a license (or agreement, like public domain), allowing anyone to study, modify, and improve the program and distribute it. Anuradha and Sivakaminathan (2009) noted that library automation software integrates all library activities, including acquisitions, cataloguing, circulation, serials, and the Online Public Access Catalogue, into an enterprise resource planning system. Singh (2012) noted that open-source software is an important tool for libraries and information centers, and various initiatives, such as Greenstone, Koha, NewGenlib and Dspace, demonstrate its feasibility. Witten and Bainbridge (2011) described the Greenstone digital library project's development over the past decade, detailing its production and research versions, and the tension between trying to support two versions of the software, and the strategy for resolving the conflict, that is, of reconciling production values with a research framework. Biswas and Paul (2010) examined Dspace and Greenstone Digital Library Software, focusing on its development, challenges, and lessons learned in developing and deploying a comprehensive open-source system for international digital library construction. Authors noted that libraries in developing countries support electronic access, digital libraries, and resource sharing through OSS. Dspace, a powerful software, allows digital document submission by members. However, it lacks METS (Metadata Encoding and Transmission Standard), making it more powerful. Roy and Kumar (2017) revealed that both NewGenlib and Koha software packages are more or less equally important in different aspects, so it is the choice for the client library/librarian to select the software on the basis of their requirements to automate their entire library system. The enhancements and improvements could be done on the basis of the conclusion drawn after the evaluation and comparison of the both ILS. Muller (2011) emphasized the significance of integrated library systems (ILS) in managing, cataloging, and circulating materials. Koha is the most international ILS with date format, MARC record type, and 25 languages, as well as OPAC usage reporting options offers cost reduction, independence, and adaptability to library needs. The Chief Librarian and decision makers should choose ILS based on its performance, efficiency, and flexibility to adapt to patron demands. Free software offers cost reduction, independence, and reinforces the mission of information dissemination.

This literature review seeks to provide a framework or guidelines for evaluating the current state of library automation and digitization at Mandya University library. By analysing the current practices and identifying areas for improvement, this article contributes to enhancing the efficiency and effectiveness of

library services at the university. Additionally, it will provide valuable insights for future planning and implementation of technological advancements in library management. Embracing change and progress will enable the library to remain relevant and influential in an increasingly digital and competitive landscape. Ultimately, this commitment to innovation will ensure that the university library remains a vital hub for knowledge dissemination and scholarly pursuits.

Methodology

As a first step, the writer sorted permission from vice chancellor and a team was set up by Registrar to conduct stock verification at constituent government college in Mandya, where a library serves as the university's information hub. As per the statistics provided by administrative staff, there are a total of 48 colleges affiliated with Mandya University. The current study focuses on analysing the information-seeking behaviour of guest faculty, with 134 guest faculty members selected from Mandya University's autonomous government institution. The campus of the autonomous government college at Mandya University has three academic educational buildings, an administration block and a new modern spectacular library building. The Registrar assessment framework and in-depth meetings were used, despite their difficulties digesting everything happening around guest faculties' problems. To meet the study objectives, several follow-ups and requests had to be made to the study participants due to the guest faculty strike throughout Karnataka.

Scope and limitations of the study

The present inquiry focused on the "Library Stock Management: Mandya University Library Scenario". The population of this article includes guest faculty members from all academic educational buildings on the campus of an independent government college. Geographically, the study is limited to a new library building, a government college, and an autonomous campus within Mandya University.

Analysis of data

Microsoft Excel's advanced functionality was used to tabulate and investigate data acquired from guest faculty members. The statistical analysis yielded calculated results and conclusions consistent with the investigation's aims.

Mandya University's Library and Information Centre is housed in a magnificent modern library block on the campus of Government College, an autonomous institution in the Mandya district. The new library building comprises 8 sections/provisional rooms on the ground floor, including a librarian room, stack area, Reference and Documentation section, library office, Periodicals, separate gents and ladies' toilet. The first level new library building houses an Apple lab, a career advisory centre, a boardroom, and a digital information resource hub. Suresh Bhat (2013-2020) who served as a college librarian at a constituent government college in the Mandya district classified and catalogued the library books based on funds using Mysore University grants. The University receives money from a variety of sources, including grants

provided by the state constituency Minister's fund, ICSSR New Delhi funds, Karnataka Border Area Development Authority, DBT – New Delhi, ICMR – New Delhi, UGC – New Delhi, MGNCRE GOKICMR, Project funds, and so on.

The library books are classified and catalogued using NewGenlib 2.1. Integrated Library Management Software (ILMS). The sources of funds are from general grants, SC and ST funds, postgraduate funds, and Undergraduate funds. This article aims to investigate the current state of application and usage of NewGenLib 2.1 software and determine the result of an intensive stock verification of more than 60,000 documents. The study also highlights how traditional document verification can be used to help identify substantial regions of loss by framing administrative criteria for collection appraisal and management policy. To achieve the study objectives, Microsoft Excel was utilized for data analysis from guest faculty members at Mandya University's Library and Information Centre, resulting in accurate library book availability in the stack area and reference and documentation section.

Table 1 examines the practices of book circulation and the arrangement of the books done in almirahs from the source of general funds. It is clear from Table 1 that more Kannada books are available from the source of general funds kept in almirahs.

It is evident how the implementation of NEP 2020 in higher educational institutions has led to a paradigm shift in the role of college librarians and the responsibilities they face in the changing educational landscape.

Table 3, 4 and 5 examines the practices of highly collaborative teaching faculties and librarian and identifies mechanisms within college that aid in high – level collaboration. A vast majority of guest faculty members indicated that collaboration is highly valued, despite limited time.

The survey enabled the writer to find out what problems the principals, faculties and students were experiencing. Table 6 identifies information about maintaining reference books for reading. In the context of Reference and Documentation section, libraries play a predominant part in providing valuable information to user community in the academic field. A study by Cox and Guthrie (2001) found that leisure

reading helps to improve students' reading comprehension and vocabulary. It is noted that Dictionaries were never used by the user community. Hamilton (2012) determined that dictionaries and vocabulary acquisition should be top priorities in the library. Students search through dictionaries very frequently, allowing them to improve their reading, spelling, and phonological skills at their own pace. Beech (2004) found that older children were more likely to search a dictionary for the meaning of words in a text than younger children. Government college libraries, regardless of their type, are struggling with lack of trained librarians and non-ICT integrated libraries.

The purpose of this present study is to examine the strengths and weaknesses of constituent government college, new library building in the Mandya district. Table 7 summarizes the current challenging issues related to the book availability in the Mandya university library. According to the report, 39127 library books are available in the constituent government college, new library building and 23060 books are discarded as loss of books. Out of 23060 loss of books, 15252 loss of books are discarded in the new library

building Mandya university library and 7808 loss of books are discarded in the old library building. As a result of the survey, insufficient knowledge of cataloguing and classification rules has hampered the quality of Mandya University Library.

Stephen (2007) noted that in the age of technology, there will be diverse opportunities to make connections online and to create participatory resources to help community users find what they're looking for, share library data and create a new impression of what libraries are in the 21st century. Government college library in the Mandya district has positive prospects for improvement, but the concerned authorities need to step forward and seriously consider the matter.

Critical Success Factors

The success and failure associated with crowdsourcing are based on the useful management of the various factors of crowdsourcing. To undertake and run a successful crowdsourcing project, there are some factors involved and its implementation requires a critical study before their application (Meier, 2010).

A study of these factors and their deviation limit can reduce the chances of failure and can increase the probability of success in full – fledged implementation for the crowdsourcing – open call for the problem solving and achieving organizational goals.

Status of College Librarian in NEP 2020

Suresh Bhatt, retired college librarian classified the books in the stack area on the basis of funds provided by the Mysore University. It has been found that managing and maintaining an Apple lab requires certain important key aspects to ensure efficiency, reliability, and longevity. Notable findings shows that insufficient knowledge of cataloguing and classification rules and therefore poor interpretation and application of these standards, lack of stationery, shortage of professional trained library staffs, manual systems, and many more. As per the UGC Guidelines for the eligibility criteria for appointment, promotions, and tenure of University/College Librarians, are the same as Assistant Professor, Associate Professor, and Professor namely, qualification, basic payment, promotional criteria, etc are same. UGC and DCE also treated librarian as a teaching faculty member. Implementation of NEP 2020 in education institutions satisfies the teaching thrust of Librarians. It is many decades of Academic librarians' dreams came into existence that librarians should treat as a teaching faculty. Hence Vice Chancellor of Mandya University should take an initiative to start the Post Graduate course of Library and Information Science in the government college, autonomous. A college library and the status of college librarian are essential and has become the forefront of education that stood at the core of delivering exceptional education to students.

Collaboration between Principal and College Librarian

In many cases, college librarians do not receive the same level of recognition and status as other guest and permanent faculty members. It is not properly implemented in higher education due to the lack of awareness about the Librarian's role. Collaboration among principals and teaching faculties is a priority for

professional and qualified librarians to be more successful. As the college librarian, the principal serves as a liaison between the college and other agencies, provides guidance to teaching faculties, and deals with teacher questions. Collaboration and support provided by the college principal is a crucial element in developing a successful library media program. The degree to which the principal understands and supports the library media program will determine how effective that

program becomes at the centre of the instructional program. Therefore it is more successful to have the principal's active support.

Library Staff in huge College libraries

Government College, autonomous comprises three academic buildings namely Science Block, Commerce Block and Humanities Block. It is considered that each building or Block on the campus should not have its library. For the whole campus, the central library and information centre are more than enough. As per the UGC Guidelines, how many library staff is required in the college depends on the strength of the student on the campus. Libraries have a high volume of books and more than 2500 students studying in the college, DCE should appoint at least one college librarian and one library assistant on the campus because the timings of opening and closing the college library are more important. In case the State Government appoints two librarians due to the more students flow to the college library, then the timings of opening and closing the college library hours needs to be from Morning 8 am to evening 8 pm. It is determined that library hour play an important role to residential hostel students and especially teaching faculties who refer notes and jot down the points to deliver the class. College library is the key to success, and nobody must be underestimated or denied that opportunity because learning and teaching should be about finding the right fit for every young mind in the nation.

Subscription of INFLIBNET NLIST-E-Resources

Though the independent Government college library subscribed to NLIST- E - resources such as e-journals and e-books are available only in English medium. As the vast majority of students are studying and speaking in the regional languages, accessing N-list resources is difficult and inconvenient for them. This leads the library to face the severe problem of providing the resources to the students at the right time. NLIST should provide e-resources on regional languages which will help the students to access maximum NLIST resources in the institution for their learning. Alternately Vice Chancellor and decision-makers need to implement personality development class; English spoken language, Placement class, and literary/ICT education programmes to the outgoing final semester undergraduate (UG) and postgraduate (PG) students in the college library. Nithyanandam et al. (2006) discussed that user education programs boost the image of the library and if combined with information technology and web-based training could be the best way to implement Ranganathan's five laws of library science. College libraries make positive contributions to student achievement as a means of strengthening the total education program.

Integrated Library Management Software (ILMS)

Librarianship involves collecting, organizing, preserving and disseminating information to those who need it. Librarians help their constituencies find and make use of information contained in a collection of various kinds, sizes, and resources to support individual needs as well as an organization's strategic goals (University of Washington, 2023). As the saying goes – garbage in, garbage out. If University/College Librarian starts library automation with flawed classification and cataloguing, will end up with flawed results. It is estimated that NewGenLib 2.1 installed at constituent government colleges needs to update their backup systems in the next coming years. This is because existing systems will be too slow or outdated to handle the speed and scale of data needed to be “data ready”.
