Murty's novels reveal her strong feminist ideas and her support for women's freedom and rights. Her literature works shows a profound awareness of gender identity and a serious concern for women's issues. Through her fiction, she portrays a realistic world that encourages critical thinking on modern views toward marriage, gender roles, Self-perception and societal expectations. She also explores the authentic social and emotional bonds women share, highlighting their adaptability as they navigate a society that balances tradition with modernity while honoring cultural heritage.

**Character Study**: The main focus is on the main characters, Mridula and Sanjai. The paper examines their characterization and personal aspirations. It discovers how they navigate their identities in relation to societal expectations, familial pressures, and personal ambitions.

**Exploration of Themes**: The paper identifies and analyzes key themes such as Gender Stereotypes, liberation, and general norms. It discusses how these themes reflected in the lives of the female protagonists and how they contribute to their personal growth and empowerment.

'House of Cards' is the story of Mridula, a simple and smart girl who is full of love and enthusiasm. She is intelligent and an honest girl who believes in doing the right things always. She stays with her parents and her brother in Alladahalli, a small village in North Karnataka, Where all of them want to be a doctor or an engineer, whereas Mridula chosen to be a teacher.

Sanjay, a doctor, meets Mridula at a marriage in her village and falls in love with her. They get married and move to Bangalore. Sanjay goes on to complete his post-graduation and Mridula joins a government school as a teacher. After getting frustrated in a Government job, Sanjay moves into private practice. Though Mridula and Sanjay move up in status and wealth they eventually drift apart after twenty five years from each other in thoughts, words and deeds. Mridula being an honest person expects the same from her husband too, but she is shocked when she comes to know that he has been hiding something from her and having his own secrets, especially in financial transactions. How can Sanjay open an account without telling me?(HOC, p.183). He is the one who said, "I don't want to handle money. You manage it and I'll manage the nursing home."(HOC, p.183). She had lost all her confidence, aggrieved, and shocked and also became annoyed. She didn't believe that her faithful husband Sanjay had cheated her. He had inculcated restlessness in her. She had lived with complete belief and trusted him from the first day of the marriage and condemning her belief that he had maintained parallel financial elsewhere. He cheated her with the incident of 10 lakh DD sent to his mother, gift deed of a car given to his sister's son Anil and made a joint fixed deposit with his sister for fifty lakh. It was not about the money but she blindly believed that her husband is honest and truthful but he had stabbed her in the back.

She was filled with shock and anger. 'I can't believe that Sanjay has cheated me like this,' she said to herself. 'I have lived with complete belief and trust in him ever since we got married. How am I going to live with him for the rest of my life? (HOC, p.184). Being a dedicated, beautiful, sincere and hardworking wife, she enabled him to reach the highest position in the medical profession. But very soon he ignored in many ways, which made her depressed.

After twenty five years of being married, Mridula harbors few illusions about her relationship with her husband. She was so depressed and decided to meet a psychiatrist. The doctor says to Mridula, Money makes him feel powerful. He has an inferiority complex and an old value system where men are supposed to be the dominating partner. Unlike you, he's a complicated person. That's why he's never established good communication with you(HOC, p.214).

She thought, If I continue staying here and in the same atmosphere, then I have to live life on my terms, if I want to be happy. And that's not possible with Sanjay around. He ridicules and dominates me and it affects my confidence terribly. I can't take it anymore. I have to do something. But what? (HOC, p.216).

Misunderstanding due to differences of opinion, failure to satisfy others all expectations, non-transparent in financial transactions and other activities are common to many married person today. However, these perfect couple failed to understand that perfect relation was to be created and not found. This served as the main cause for this couple to separate and pursue their objects of desire.

At the fine time her son Sishir realized and wondered, 'what authority does my mother have in any household decisions except in the kitchen? She doesn't have freedom anywhere. Everywhere, my father makes the decisions and my mother has to follow them. But no one ever tells my father about my mother's sufferings or his mistakes. Though she has sacrificed a lot, she is still a non-entity' (HOC, p.229). The author clearly explains in this book 'Every woman wants to change her life but no man understands how. He showers his wife with gifts that he likes but not with what she wants'. In India, when you marry a person, you also marry to his family. By default, people expect you to adjust to the husband's family. In India patriarchy is the prevalent system, and across various spheres of society is largely male-dominated. Murty demonstrates marriage as a patriarchal institution that binds women to a lifetime of male domination.

The author's protagonist was not like everybody, she was different. She had enormous enthusiasm for life and unlimited energy. She wanted to spend every minute of the day fruitfully. It seemed that the sun rose for her and the rainbow colours were meant only for her. Every day was to be lived to its fullest and every beautiful minute to be enjoyed. SudhaMurty's protagonists struggle to break the clutches of suffocating relationships which results in marital dispute.

The study of Feminism and Gender theory requires constant retrospective rework and revisions to facilitate rehabilitation and transformation in people. By emphasizing feminism, male chauvinism, trust, dishonesty, self-identity, and Self-perception offers a feminism approach that seeks to identify the self. Thus, this is a very well written book and the story is about how dishonesty can hamper a relationship between husband and wife. SudhaMurty brings us the story of a common person, someone we can relate to and that is what makes her books so special. "Women contribute significantly to the functioning of society and the economy.
