The girls are killed by their partners for the small & inappropriate reasons. In india, we record 82 murder cases per day. Overall, Delhi has registered highest number of murder cases and Nagaland has registered the lowest number of murder cases in our country. We hear the most shocking & terrifying case of delhi which got highlighted after the 6 months of the murder of the victim & assailant kept the chopped parts of the body in the fridge.

We carried out the survey through google form from the people around our surroundings & area to know what the people think or aware about the safety & protection of the women's & girls. We also took the help of the browsers & google to collect the information of the various cases happening nowdays in our country. We talked with the people around us & we came to know about the conclusion that most of the people are aware about the safety measures taken by our government. We also took the help of the sources which helped us a lot in the research work.

Research methodology :-

When I was carrying out my survey so I noticed that some of the people's were not aware about the safety measures taken by our higher authorities (i.e. government, law enforcement officers,etc.) for protecting the women's of our society. I am sharing my experience which I got while carrying out the survey.

One day, while I was walking through the road I heard the shocking & terrifying murder case which was happened in the city. Early in the morning, Mr. 'x' was the husband going to the work place at 9:00 am from his house. While leaving, he forgot something to carry car keys to the office so he came back inside the house & asked his wife mrs.'x' to give her that car keys. So, she started to prate & mr.'x' heared it. So, he started to argue with her and later on this argument turned into a fight. After a while, mr.'x' picked up the glass in the anger and accidentally attacked on his wife. Mrs.'x' got hitted in the head harshly & she fell down & she called off dead. So after seeing the dead body of his wife mrs.'x', he gets shocked & hesitated because that was done accidently not impulsively. After few minutes, he decides to hide the incident that was happened accidently by him. At that late darknight, he takes the dead body of his wife to the dark forest & push down from the peak of it and he returns back home after 3-4 hours. After 15 days from that day, the police finds the unidentified dead body of the women in that forest. So, they circulate the photos & tries to identify that women. After 5 days of effort taken by police, they gets the identification of the women which was recognized by her neighbours. They also told the police that her husband was ran away from that place suddenly & he was frightened about something. After 20 days, they found mr.'x' in another part of the city & caught him & was brought to the

police station. After interrogating him, he commits that the murder of his wife mrs.'x' was accidently done by him & because of the fear he tried to hide this incident done by him. Thereafter, he was penalized by the IPC SEC 302 (punishment for the murder) & IPC SEC 201 (causing disappearance of the evidence or the offence). He got punishment of lifetime imprisonment. After IPC SEC 302,this act is non-bailable & non- compoundable.

Safety measures for women's in our society :-

We should take some of the necessary steps & precautions for the protection & safeguard the women's of our society. The government of our country already launched lots of schemes & forces for the protection of the women's. We will discuss some of the important schemes that were launched for the protection of the women's of our society :-

- 1.Ujjawala :- A comprehensive scheme for Prevention of trafficking and Rescue, Rehabilitation and Reintegration of Victims of Trafficking and Commercial Sexual Exploitation.
- 2.Nirbhaya fund :- These funds are used to improve the women's safety & security projects.
- 3.Shakti app :- The state of himachal pradesh has launched the "shakti app" for women's safety that allows women's to send a distress call to the police.

These are the some of the schemes that are launched by the various government's to protect the women's & girls in our society.

- According to me, these should be the steps or measures taken by the people to safeguard our women of our society.
- 1. We should give parenting to our sons to how to respect the women's & girls in our society.
- 2. We should teach each & every girl in our country to self-defence themselves from the evil eye people of our society.
- 3. We should support our women's to come in front & speak out themselves in front of the peoples.
- 4. We should also develop some of the more apps like "Shakti" to help the women's & girls in the disguise.
- 5.We should make schools to implent the value of the girls in the society by taking sessions for it.

- 7. Promoting and protecting women's rights at national level.

- 9.We should strict more laws & acts so that the assailant (attacker) would be frightened to create an crime.
- 10. We should provide more funds through the local authorities & government's to support the projects conducted for safety & protection of the women's of our society.

We know that our government of india has IPC (Indian penal code) acts to justify the crimes as per the case or incident. If there is a case of robbery or fraud it is considered under the IPC act (392). They gets penalized by the (sec 392) i.e.(punishment of robbery) which means whoever commits robbery shall be punished with rigorous imprisonment for a term which may extend to ten years, and shall also be liable to fine. If there is a case of violence or the murder it is considered under the IPC act (302) i.e. (punishment for murder) whoever commits murder shall be punished with death or (imprisonment for life), and shall also be liable to fine. In this,


we came to know that according to the government & ipc sec, as the case or incident is intense that the charges that will get penalized or punishment will be more stern.

Here are some of the questions that were asked for the survey to know that how much people are aware about the safety measures & the IPC sections of our country.


Count of 1. WHAT DO YOU FEEL CRIME'S AGAINST


